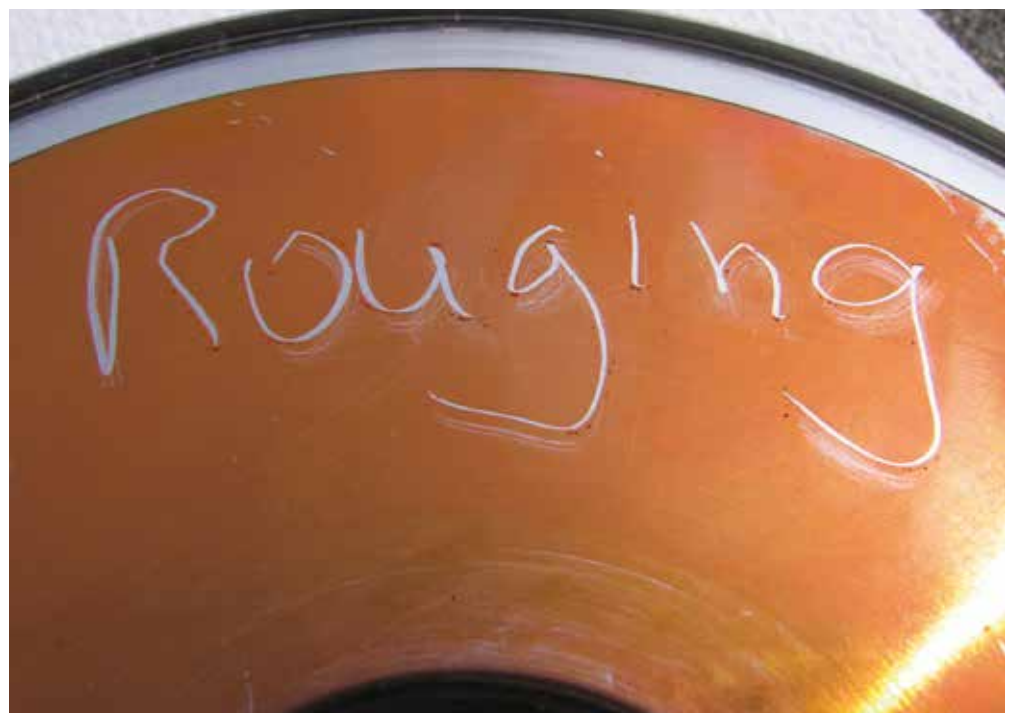

Water is the most frequently used excipient in pharmaceutical production in terms of quantity. Therefore, microbiological monitoring of plants for the production and distribution of pharmaceutical water plays a central role in any microbiological control strategy. The aim of this webinar is to provide an overview of microbiological monitoring of water systems in accordance with international guidelines.
