## Background

Microbiological testing is present in several stages during development and manufacturing of any drug product or raw material (excipient, drug substance, primary packaging). There is huge number of different microbiological tests. The goal of this webinar is to give an overview of the most important microbiological tests (such as sterility test, bioburden test, identification and evaluation of isolates, endotoxin testing, growth promotion test, preservation test, environmental monitoring or container closure integrity) and will give some ideas on alternative or rapid microbiological testing.

## Educational Objectives

This webinar aims at giving you a compact overview about the most important microbiological testing methods of sterile as well as non-sterile products according to the current regulations.
